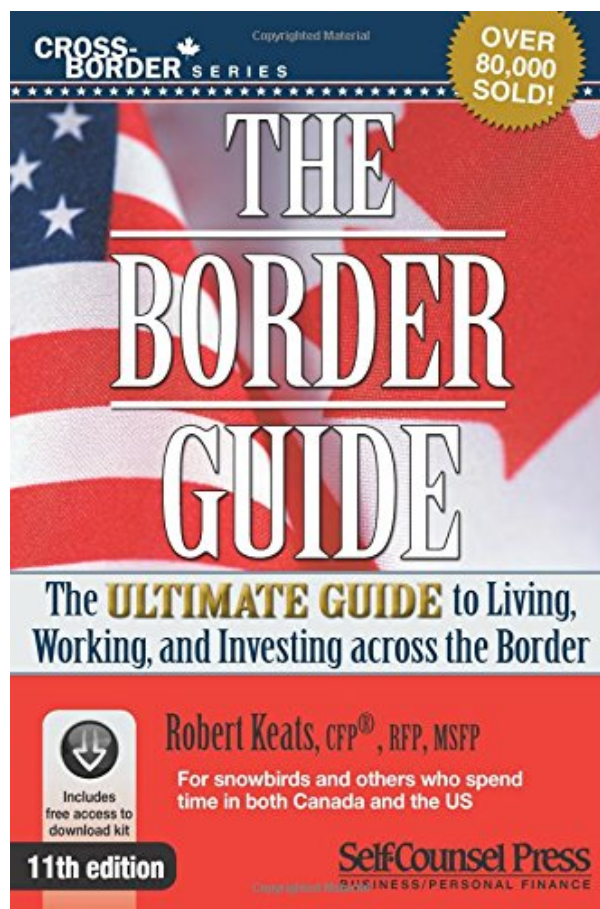
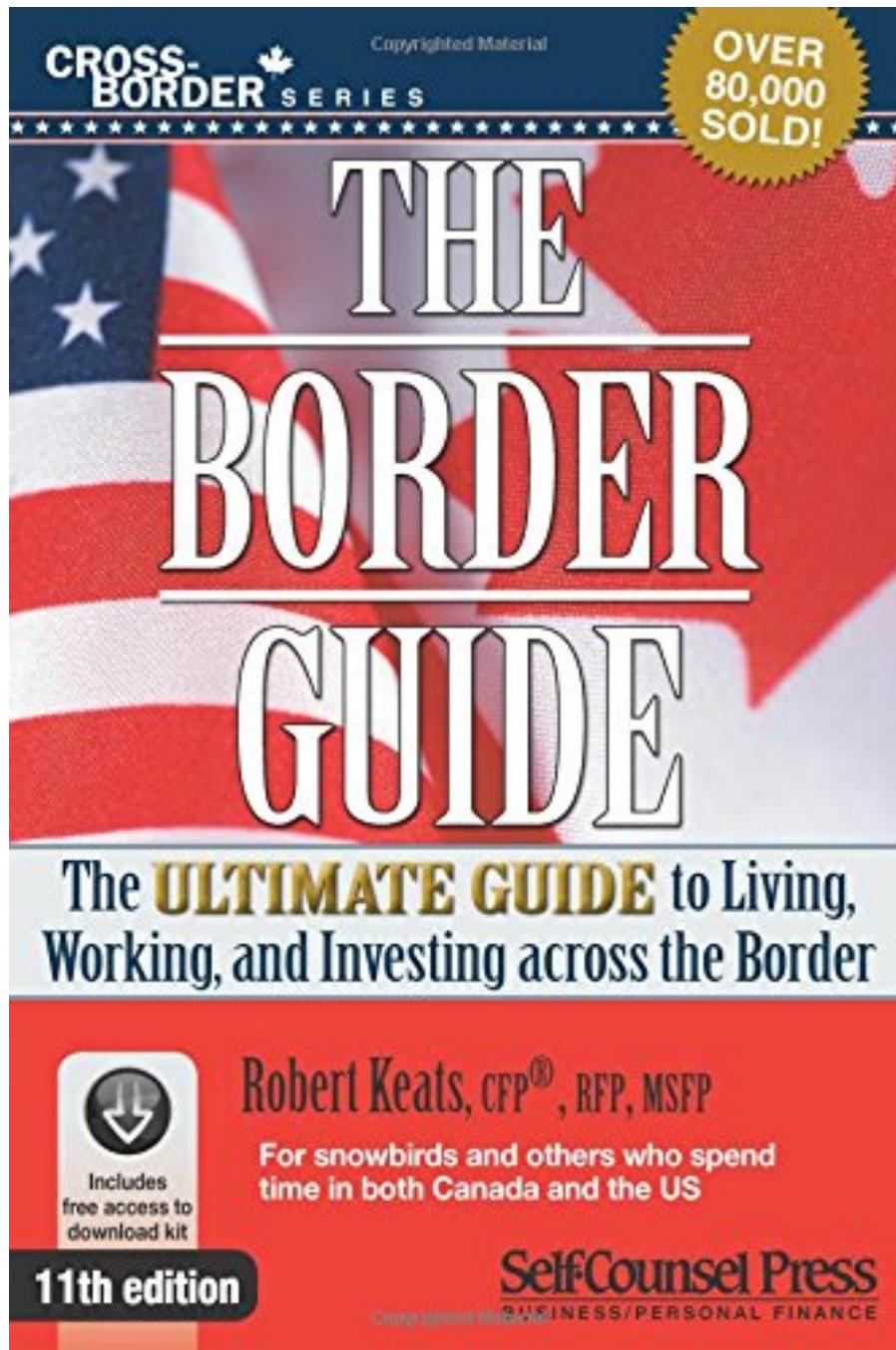

This book is a good start to understanding the differences in the systems. HOWEVER, the book is highly biased. Comparisons provided are not done fairly. If your income is less than approx. \$60k CDN per year (likely most retirees), you will likely pay less overall tax/costs in Canada. If you retire before 65, or not eligible for US Medicare, you will need to pay Healthcare in USA, easily \$6k per year, with a high deductible (you pay the first say, \$5k of expenses each year, plus 6k premiums). Property taxes can be high, depending on the state (a \$500k home in California can cost you about \$6k/yr in property tax). IF you have children, you may need to consider private school (\$\$\$) depending where your home is located. Cost of living can be less or more, depending on the city your moving from /to, so don't blindly follow the recommendations of this book. Do your own investigation and use this book as a resource.

Financial and tax issues can be daunting, especially when people have property or finances in both countries. With the tighter restrictions now placed on U.S. citizens living in Canada, this is a book to get, read, study and act on. The book itself is authored by a consultant whose firm specializes in U.S.- Canada issues for cross-border folks, and it may be a good idea for those with serious financial matters to contact the firm.
